BID NOTICE UNDER OPEN BIDDING

Supply of electric fencing materials for electric fence construction in MFNP, QENP & KVNP– UWA/SUPLS/25-26/00015.

1. The Uganda Wildlife Authority has received funds from Government of Uganda to be used for the acquisition of electric fencing materials for electric fence construction in MFNP, QENP & KVNP.
2. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, Cap 205, and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from **8am to 5pm**.
5. The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **UGX 200,000** (Uganda shillings two hundred thousand only). The method of payment will be **cash**.
6. Bids must be delivered to the address below at 8(c) at or before **11.00am on 7th November 2025**. All bids must be accompanied by bid security of;
 - **Lot One (Electric fencing material for construction of 100km electric fence in MFCA)- UGX. 34,500,000.**
 - **Lot Two (Electric fencing material for construction of 50km electric fence in QENP)- UGX. 15,200,000.**
 - **Lot Three (Electric Fencing material for construction of 60km electric fence in KVCA)- UGX. 18,300,000.**

Bid security must be valid until **17th June 2026**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11.15am** on **7th November 2025**.

7. There shall not be a pre – bid meeting/ site visit.
